### Drug:

**I** - 4,4-dimethyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol

**II** - 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, 3-acetate

**III** - 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, diacetate

### Drug Name Status:

**I** - 4,4-dimethyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol is the common name

**II** - 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, acetate is the common name

**III** - 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, diacetate is the common name

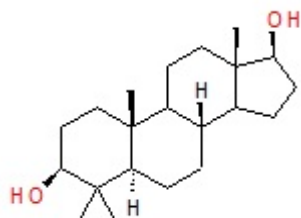

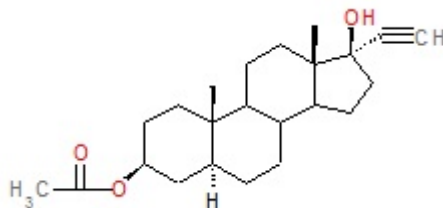

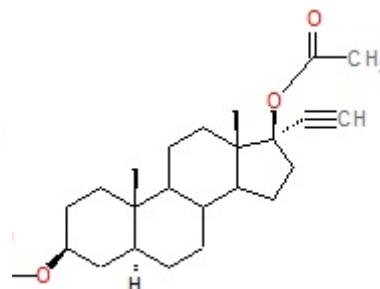

**Pharmacological class / Application:** steroid

**International status:**

US: The substances are not listed on the schedules to the CSA and are not mentioned on the DEA website.

United Nations: The substances are not listed on the Yellow List - List of Narcotic Drugs under International Control. The drugs are not listed on the Green List - List of Psychotropic Substances under International Control.

Canadian Status: 4,4-dimethyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, 3-acetate and 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, diacetate are synthetic steroids and have not been reported in the literature to display any anabolic activity.

Recommendation: 4,4-dimethyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, 3-acetate and 17 $\alpha$ -ethynyl-5 $\alpha$ -androstane-3 $\beta$ ,17 $\beta$ -diol, diacetate are not included in the schedules to the CDSA and are not controlled substances.
