
Drug Status Report

Drug: WIN 55,212-3

Drug Name Status: WIN 55,212-3 is the common name.

Chemical Name: (S)-(-)-[2,3-Dihydro-5-methyl-3-(4-morpholinylmethyl)pyrrolo[1,2,3-de]-1,4-benzoxazin-6-yl]-1-naphthalenylmethanone

Pharmacological class / Application: Cannabinoid receptor antagonist

International status:

US: The substance is not listed specifically in the CSA and is not mentioned anywhere on the DEA website.

United Nations: The substance is not listed on the Yellow List - List of Narcotic Drugs under International Control, the Green List - List of Psychotropic Substances under International Control, nor the Red List - List of Precursors and Chemicals Frequently Used in the Illicit Manufacture of Narcotic Drugs and Psychotropic Substances under International Control.

Canadian Status: WIN 55,212-3 is not currently listed in the Schedules to the CDSA. The substance is a synthetic cannabinoid and an isomer of the cannabinoid receptor agonist WIN 55,212-2. While WIN 55,212-2 has been reported to be an efficacious cannabinoid receptor agonist and deemed to be included under item 1 of Schedule II to the CDSA, WIN 55,212-3 has been shown in the scientific literature to be an efficacious antagonist at the cannabinoid

CB₂ receptor¹. Cannabinoid receptor antagonists have been declared to fall outside the heading "Cannabis, its preparations, derivatives and similar synthetic preparations, including" of item 1 of Schedule II to the CDSA. Therefore, WIN 55,212-3 cannot be included under item 1 of Schedule II to the CDSA.

Recommendation: WIN 55,212-3 is not included in Schedule II to the CDSA and is not a controlled substance.
